The terms hereof are part of the contract for the goods and shall prevail in the event of any conflict between these terms and the terms of the order.

**2. Warranty:** The goods herein listed are purchased " AS IS WHERE IS" and no other warranties are expressed or implied unless otherwise defined. Alandra Services also makes no warranties as to fitness for a particular purpose.

**3. Copyright:** Copyright laws protect many Original Equipment Manufacturers' (OEM) products. The purchaser as their sole responsibility must arrange for any document or software requirements or duplications.

**4. Shipping:** All shipments are made Ex Works "Origin" or designated location. Title and all risk of loss or damage to the goods will pass to the purchaser upon delivery to carrier. All shipping cost is the responsibility of the purchaser unless specifically noted otherwise. Estimated shipping weights and dimensions are approximated which are provided as a convenience and Alandra Services will not be held accountable for the exactness of this information.

**5. Availability:** All quotations are for immediate acceptance and are subject to prior sale of the goods and to withdrawal without notice. All orders are subject to acceptance by Alandra Services in writing and no order shall be binding upon Alandra Services unless so accepted.

**6. Terms of Payment:** Unless otherwise noted herein, Terms of Payment are 100% payment prior to shipment unless otherwise noted. Funds to be sent via wire transfer (or cashiers check sent by overnight service) Company checks are acceptable, but will require that we hold your check until it clears the bank which will delay the shipment of your goods Prices quoted do not reflect any applicable federal, state, local taxes, crating and/or skidding unless noted herein. **8. Order Cancellation:** Cancellation in whole or in part of the order, or changes therein, can be made only with Alandra Services consent and upon terms that will indemnify Alandra Services against any losses.

**9. Clerical Errors:** All quotations are subject to correction for clerical errors, incomplete or incorrect information.

**10. Limit Of Liability:** Alandra Services or previous owner will in no way assume any liability or responsibility for any damages and or injuries to person and/or property resulting from the use of these goods. Purchaser agrees to assume all responsibility and agrees to indemnify and hold harmless Alandra Services and previous owner for any damages and/or injuries to person(s) or property resulting from the use of said goods.
